# RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OR RISK, AND INDEMNITY AGREEMENT

IN CONSIDERATION of my child being permitted to participate in activities offered by **MAMA'S BOYZ LACROSSE & ALL STAR ARENA, at 635 MIDDLE COUNTRY ROAD, SELDEN.**

I represent, that I the minor's parent and/or legal guardian, understand the nature of the Activity and that my child is qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I believe conditions are unsafe, I will immediately have my child discontinue participation in any such Activity.

I fully understand that the Activity involve risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my child's actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my child's participation in the Activity.

I hereby release, discharge, and covenant not to sue **MAMA'S BOYZ LACROSSE, ALL STAR ARENA**, their respective administrators, members, managers, directors, agents, officers, volunteers, independent contractors, and employees, other participants, any sponsors, advertisers, and the owners and lessors of the premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses, or damages on my account or my child's account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk I, my child, or anyone on my child's behalf including but not limited to my spouse, heirs, personal representatives, or assigns, makes a claim against any of the Releasees, in their own right or on behalf of my child, I will indemnify, save, and hold harmless (that is, defend and pay any judgment and costs, including investigation costs and attorney's fees) each of the Releasees from any loss, liability, damage or cost which any may incur as the result of such claim.

This document is a document is a legal and binding contract, which supersedes any other agreements, or representations by or between parties and which is intended to provide a comprehensive release of liability, but is not intended to assert any claims or defenses which are prohibited by law. If any portion of this Agreement is deemed unenforceable, the remainder shall be given full force to and effect.
